The purpose for data collection is to trace the chain of infection of the SARS-CoV-2 virus ("coronavirus") as quickly as possible.

Your information is transferred exclusively to and upon the request of our responsible health department or local police department.

The legal basis for this is Article 6 Para 1(c) of the General Data Protection Regulation (GDPR) in conjunction with the Ordinance of the State Government on Infection Protection Measures against the Spread of the SARS-CoV-2 Virus (Corona Ordinance - "CoronaVO") of September 15, 2021.

We will retain your personal data for four weeks, upon which it will be destroyed/deleted.

You are not required to provide your personal data and the provided information will not be verified. However, if you opt not to provide your personal data, we will unfortunately not be able to allow you to visit our monuments or attend our events.

Note regarding data subject rights as per the GDPR:

You have the right to information regarding your stored personal data (Art. 15 GDPR). In the event that incorrect personal data is processed, you have the right to rectification (Art. 16 GDPR). Should legal precedent exist, you may request the deletion or restriction of processing and have the right to object to processing (Art. 17, 18, 21 GDPR). The right to request deletion is excluded in the presence of a legal regulation for the continued retention of your data. In such a case, the deletion request can only be complied with once the legal retention period has passed. Should you exercise your above rights, we shall verify that the legal requirements are met.

You also have the right to appeal to a data protection regulatory authority. Our responsible office is: Landesbeauftragte für den Datenschutz und die Informationsfreiheit Baden-Württemberg, Königstrasse 10a, Stuttgart.
